

**Hollywood Acting Workshop Actor Contract and Cancellation Policy**  
**(as required by the California Labor Code Section 1701-1705.4)**

Hollywood Acting Workshop's bond number is **W150194872** in the amount of \$50,000 underwritten by Old Republic Surety Company, 18300 Von Karman Avenue, Suite 640, Irvine, CA 92612-1031 and is mandatorily filed with the Labor Commissioner of California.

The contract (below) covers the services of an Instructor/Class or Casting Director/Associate Workshop or Agent/Manager Showcase. The Instructor or Casting Director/Associate or Agent/Manager will speak to the actors attending, answering questions at the start or end of the educational class/workshop/showcase in regard to how their office operates, insights into the industry, how to be a successful actor, acting techniques, etc. Each actor will perform a scene or monologue (excluding those from television, film or commercial that have not already aired or previously been cast) in front of the entire class and the Instructor or Casting Director/Associate or Agent/Manager. The Instructor or Casting Director/Associate or Agent/Manager may choose to provide a written critique and/or verbal feedback as to how an actor can improve their performance. Other actors will view these performances as it is an excellent learning tool. In addition to the Q&A portion, actors will view a 30- to 45-minute informational portion (by the Instructor or Casting Director/Casting Associate or Agent/Manager), live or a video, that is full of practical up-to-date information on acting, audition techniques, the industry, how to get repped, marketing yourself, headshots/resumes, networking, social media, unions, and much more. Each workshop is between 2-3 hours in duration.

You may cancel the contract (below) and obtain a full refund, without any penalty or obligation, if notice of cancellation is given, in writing, within 10 business days from the date of contract or the date on which you commence utilizing the services under the contract, whichever is longer.

**YOUR RIGHT TO CANCEL (the aforementioned Class/Workshop/Showcase): YOU MAY CANCEL THIS CONTRACT AND OBTAIN A FULL REFUND, WITHOUT ANY PENALTY OR OBLIGATION, IF NOTICE OF CANCELLATION IS GIVEN, IN WRITING, WITHIN 10 BUSINESS**

**DAYS FROM THE ABOVE DATE OR THE DATE ON WHICH YOU COMMENCE UTILIZING THE SERVICES UNDER THE CONTRACT, WHICHEVER IS LONGER. FOR PURPOSES OF THIS SECTION, BUSINESS DAYS ARE MONDAY THROUGH FRIDAY. AFTER 10 DAYS, CANCELLATIONS ARE PROHIBITED.
